All other Schedule IV drugs	Any amount	<b>First Offense:</b> Not more than 3 years. Fine not more than \$250,000.  <b>Second Offense:</b> Not more than 6 years. Fine not more than \$500,000.		
Flunitrazepam (Schedule IV)	Less than 30 milligrams			
All Schedule V drugs	Any amount	<b>First Offense:</b> Not more than 1 year. Fine not more than \$100,000.  <b>Second Offense:</b> Not more than 2 years. Fine not more than \$200,000.
